INFORMATION, TERMS, CONDITIONS & LIMITATION OF LIABILITY STATEMENT

The terms, conditions and limitation of liability under which cruise tours are organized and operated by Centre One Cruising are detailed hereunder, and the payment of the cruise tour deposit or the cruise tour price represents acceptances by the purchaser of the terms, conditions and limitations of liability.

BOOKINGS are to be made on the Centre One Cruising Booking Form, and must be secured by the following non-refundable, non-transferable deposit per person at time of booking.

Deposits for Cruise Tours (cruise and flight components):

- of less than or equal to 12 days duration = \$AUD1000 per person
- of greater than 13 days duration = \$AUD1500 per person

Your cruise tour will include:

1. A cruise component, (per person twin share basis)
2. Your return to Sydney/Melbourne economy airfare
3. Transfers, Pre and Post accommodation as detailed in the selected cruise tour,
4. On board gratuities
5. An escort tour director who will be available at all times until your return to Sydney/Melbourne

Upon booking, a **CONFIRMATION** will be forwarded to the passenger within seven (7) working days. We draw your attention in particular to the fact that we **strongly recommend you take out travel insurance at this time.**

The balance of all fares must be received by Centre One Cruising and applied to the booking no later than 90 days prior to the departure date.

CANCELLATIONS made before the advertised date of departure will incur charges per person according to the table below:

91 days or more	Loss of Deposit
90 to 61 days	25% of total fare
60 to 31 days	50% of total fare
30 days or less	100% of total fare

All airfare components of a cruise tour are non-refundable for cancellations made inside 60 days prior to the departure date. Airfare conditions are subject to change without notice and will be those applicable at the time of ticketing.

It is essential that full passport name and details are given to Centre One Cruising at the time of booking. Any correction per booking to a passenger name before tickets/vouchers have been issued will be subject to a charge of \$AUD50 per person on each occasion.

AIRFARES are included in your cruise tour package. The return to Sydney/Melbourne economy airfares are included, however it may not include fees and taxes, nor fuel surcharges which may be applicable: these will be quoted at the time of booking. Costs of transfers and baggage handling between the airport and ship or hotel (and vice versa) on the day of embarkation/disembarkation only are included. Airline baggage restrictions apply. Airfares do not include stopovers or stopover accommodation.

Airfares and conditions of passage are subject to change without notice, and we reserve the right to change the fare applicable at the time of booking. Bookings are subject to limited availability and the applicable airline conditions apply. Air fees, taxes and surcharges may include any and all fees, charges and taxes related to air transportation imposed by Australian and/or foreign governmental or quasi governmental authorities including airport facility charges, departure taxes, security taxes and surcharges, airport service charges and government inspection fees. The air fees, taxes and charges may be separately quoted at the time of booking.

Air flights are part of your cruise tour package and cannot be varied. Any variation will be at the passenger's expense.

AIR TICKETING: Centre One Cruising will issue, as an agent only, documentation for travel on flights and airlines for your cruise tour, subject to airline schedules and availability. Centre One Cruising cannot accept any responsibility for changes in airline schedules and seat availability necessitating additional hotel accommodation. Centre One Cruising reserves the right to pass on any additional or increased taxes that the relevant authorities require to be collected on the ticket, after flights have been booked.

Centre One Cruising accepts no responsibility for losses or additional expenses due to delays, or changes in connecting services, sickness, weather, strikes or political protest or other causes. All losses will be borne by the passenger.

HEALTH: Passengers' wellbeing is our foremost concern and any recent/current physical or mental condition that may require medical attention or special treatment, must be advised to us at time of booking. We recommend seasonal influenza vaccinations for all passengers.

LIMIT OF LIABILITY: The itinerary is a guide only. Centre One Cruising reserves the right to cancel/alter/change aspects of the cruise tour at any time, for any reason as may be necessitated by international events, operational conditions including weather, and non performance of suppliers. Centre One Cruising accepts no responsibility for losses or additional expenses due to delays or changes in contract services, sickness, weather, strikes or international unrest. Centre One Cruising will take all reasonable steps to provide an enjoyable cruise tour, however, it accepts no responsibility or liability for any loss of enjoyment whatsoever and howsoever experienced by a passenger.

PRICE INCLUDES: International airfares on the nominated carrier and ticketing fees associated with the air passage: transfers from the destination airport to the ship and/or hotel, pre and/or post cruise accommodation, local tours etc. as detailed in the cruise tour. Priority embarkation and disembarkation procedures, full board accommodation (at the stated level) for the duration of the cruise, and all main meals on board (except food at alternative dining venues), shows and entertainment, and the use of the ship's many complimentary facilities.

PRICE DOES NOT INCLUDE: Air taxes and charges, as well as fuel surcharges levied by the airline, are not included.
